We developed a system so each booth gets a consistent flow of traffic. Which ensures the Truckers and Exhibitors interact. Each Trucker will receive a " TRUCKERS PASS " at time of registration. The Trucker must ask a QUESTION that pertains to the Exhibitors booth/company in order to receive a stamp on the " TRUCKERS PASS " by the exhibitor. The " TRUCKERS PASS " will then be redeemed by the trucker for prizes. The prizes will depend on the amount of exhibitors they have visited that day.

- All exhibitors must provide proof of liability insurance (\$2,000,000 coverage). Insurance Binder with **County of Los Angeles and United States Army Corps of Engineer** as additional insurers must be submitted via fax to our office by July 13, 2011
- Exhibiting Company **MUST have Workers Compensation Coverage** and submit proof by July 13, 2011
- If you must use your personal/company vehicle* to drive on Exhibitor Area to set up booth, you **MUST** fax proof of car liability insurance to our office before July 13, 2011
- * All Vehicles must leave Show premises immediately after unloading equipment.

Truckers Wanted Truck Show can provide special event liability insurance only to exhibitors for an additional fee of \$70.00*.

* This fee secures liability insurance for exhibitor on event day and show premises only.
